At CMClient, we are committed to protecting your privacy and personal information. This Policy explains how we collect, use, and share information about you when you use our Services.

By using our Services, you agree to the collection, use, and sharing of your information as described in this Policy. If you do not agree with our policies and practices, do not use our Services.

Types of Personal Information Collected

We collect several types of information from and about users of our Services, including:

- Information that we collect automatically: When you use our Services, we may collect certain information automatically, such as your IP address, device type, browser type, and information about your usage of our Services.

Use of Personal Information

We use the personal information that we collect to provide, maintain, and improve our Services, and to communicate with you. For example, we may use your personal information to:

- Create and maintain your account

Sharing of Personal Information

Data Security

We take reasonable measures to protect the personal information that we collect from unauthorized access, use, or disclosure. However, no data transmission over the internet or storage system can be 100% secure, and we cannot guarantee the security of your personal information.

Data Retention

We retain the personal information that we collect for as long as necessary to provide our Services or as required by law.

User Rights

You have the following rights with respect to your personal information:

- The right to erasure: You have the right to request that we delete your personal information.

- The right to object to processing: You have the right to object to the processing of your personal information.
- The right to data portability: You have the right to request that we transfer your personal information to another organization or to you.
